

INQUIRY PROCESSES

1. The terms of reference asked us to provide the Indigenous people and their organisations, and all relevant agencies, with adequate opportunities for input into the Inquiry. The Commission placed a high value on the involvement of organisations and people who may be affected by the findings of the Inquiry. It considered that as well as speaking with government agencies that fund and/or provide services, it was particularly important to speak with Indigenous organisations, communities and individuals.

2. Attachment B of the Main Report details some features of the Inquiry process. These included:

- (i) the distribution of a Commission Information Paper in February 2000;
- (ii) a workshop of researchers in Indigenous affairs to discuss possible approaches to the measurement of Indigenous needs in April 2000;
- (iii) provision of written submissions by government agencies, Indigenous organisations, research centres and individuals;
- (iv) Commonwealth and State Government Agency Conferences;
- (v) the Consultation Program;
- (vi) the circulation of a draft report in October 2000;
- (vii) Draft Report Conferences around Australia; and
- (viii) provision of final written submissions.

The Submissions

3. Written submissions were provided at two stages of the Inquiry, from April 2000 following the release of the Information Paper (Discussion Paper 2000/1) in February 2000, and from December 2000 following the release of the Draft Report (Discussion Paper 2000/2) in October 2000.

The Consultation Program

9. The Consultation Program was the key activity in the Inquiry process which allowed the Commission to provide the Indigenous people and their organisations, and all relevant agencies, with opportunities for input into the Inquiry.

10. The Consultation Program included wide-ranging visits around Australia to discuss Indigenous needs and the services provided to meet them. Meetings were held with ATSIC Commissioners and representatives of ATSIC regional councils, State and local government agencies that provide services to Indigenous people, and with Indigenous organisations and communities.

11. In total, over 150 meetings were held, involving approximately 250 organisations. By the end of the program, 24 of the 35 ATSIC regions were visited, plus the Torres Strait Islands.
