Collection Overview

Scope and contents note

This collection is comprised of tape transcriptions and fieldnotes collected and created by Audrey Bolger. Her research was conducted in the Wangkajunga (Kurungal) Community at Christmas Creek, West Kimberley, WA from 1982 to 1984. Audrey Bolger deposited the material with AIATSIS in September 2011. The contents describe different aspects of the Community such as biographies, economics, history and law. The collection is divided into two series: (1) Tape transcriptions and (2) Papers about Christmas Creek.

Provenance

In September 2011, Audrey Bolger deposited the material related to her research about the Wangkajunga (Kurungal) Community at Christmas Creek. The contents include fieldnotes, colour slides, audio cassettes, tape transcriptions and photographs.

Material separated from the collection

No material has been separated from this collection.

Related material

In keeping with current AIATSIS collection archival practices, the colour slides and photographs were transferred to the Photographic collection and the audio cassettes were transferred to the Audiovisual collection.

The colour slides (BOLGER.A01.CS) and photographs (BOLGER.A01.DF) have been digitised.

Biographical history note

Audrey Bolger was a lecturer in the Department of Social Work and Social Administration at the University of Western Australia when she conducted research in the Wangkajunga Community. She obtained a Bachelor's degree from the University of Papua New Guinea and a Master's degree from York, England.

In 1972, Bolger undertook fieldwork in the Province of Madang in Papua New Guinea, assisting with research on the national election held that year. From 1974 to 1975, she conducted research in the settlement of Ugandan Asian refugees in Bradford and York, England. From 1976 to 1980, Bolger's research focussed on political developments amongst Aboriginal Communities in the Kimberley area of Western Australia. This involved several visits to Aboriginal Communities in the West Kimberley, WA.

In 1981, Bolger received an AIAS Grant to undertake a study at Christmas Creek station, near Fitzroy Crossing, West Kimberley, WA, entitled Study of economic change among women of the Wangkatjunka [Wangkajunga] Community. The research focussed on the social situation and economic activities from the perspectives of Aboriginal women. In 1983, the AIAS provided Bolger with a limited (emergency) grant to support the continuation of her research. Bolger created and collected this material during fieldwork funded by these grants. Audrey Bolger published several papers and reports based on the material in this collection. See AIATSIS collection PMS 2584 (Women's work - productive or non-productive) and MS 2466 (Kurungal women: socio-economic change amongst women of the Wangkajunga Community, Christmas Creek).

In 1986, Bolger received third AIAS grant entitled The impact of public sector activity on Aboriginal Communities in the East Kimberley region, WA. This grant was part of the East Kimberley Impact Assessment Project; a multi-disciplinary project designed to assess the social impact of major resource developments on Aboriginal Communities within the East Kimberley region. The project also established a framework to enable Communities to develop their own strategies for managing social impact issues.

Series Description

Series 1 Tape transcriptions

AIATSIS audiovisual collection BOLGER_A01 includes the audio recordings collected by Bolger during fieldwork in 1982. Audrey Bolger deposited the audiotapes along with the transcriptions in 2011. They record the lifestyle, individual and family histories and local peoples' work at pastoral stations.

1 Tape transcriptions - Olive Bieundurry

Transcriptions of Tape 11 and Tape 12.

2 Tape transcriptions - Christmas Creek

Transcriptions of Tape 1, 2, 2a, 3a, 5, 6, 7 and 10.

Series 2 Papers about Christmas Creek

This Series contains papers about Christmas Creek including biographies, economics, history, law and events. The papers were collected through interviews and participant observation.

Folder / Item

1 Kroonul [Kroonull](Christmas Creek, Ngumban, Windmill) - background (1976-1980)

Background information of Kroonull Community, including people, place and development.

2 Wangkujunga - history

Information of local history from the readings and the interviews.

3 Christmas Creek - general

Notes about Wangkajunga Community, alcohol, children, Christianity, education, families, health, culture, law business, woman's law, marriage and kinship, deaths, dreaming, sacred place, single girls, transport, etc.

4 Christmas Creek - population, houses and families

Notes about population, family members, and State Housing Commission (SHC) house allocation in 1982. Close access - contains families and personal information.

5 Christmas Creek - economic

Notes about bush food, hunting and gathering, clothes, employment, SHC housing, Community housemaker, station and store.

6 Christmas Creek - biographies (Group 1)

Close access - contains personal information and genealogies. Original transcription of tape 2a, 3a, and 10 are included (see also Series 1, Item 2).

7 Christmas Creek - biographies (Group 2)

Close access - contains personal information and genealogies. Original transcription of tape 1, 5 (see also Series 1, Item 2), and 4 are included.

8 Christmas Creek - biographies (Group 3)

Close access - contains personal information and genealogies. Original transcription of tape 6 (see also Series 1, Item 2) is included.

9 Jitaparru School (1984)

Newspaper clippings, correspondence, and notes about establishing a secondary school in the Wangkajunga Community. The Community attempted to improve

Aboriginal education, obtain more control of what their children are taught at school, and create an environment for the children to learn their own language and culture.

10 Christmas Creek 1984-1985

Newspaper clippings of events in the Wangkajunga Community in 1984-1985, such as Kimberley pastoral stations selling, land bid, Aboriginal women's rights and accidents. Notes about accidents, houses, land interests, law, women's law, and Well 33 on the Canning Stock Route (CSR). Regional proposal - Community workers' staff tool. Correspondence about Project Officer of Junjuwa and Wangkajunga Community.
