The W.A. Land Register is organised into six regional areas – Perth, Kalgoorlie, Geraldton, Port Hedland, Broome and Kununurra and comprises a total of 62 application forms, ranging from 1973 to 1985 and 4 blank application forms. Each application form comprises several data fields, with only the following fields described in this Finding Aid: Register file No., Community name, Tribe, Location of the community, and Property name(s). All forms are printed unless otherwise stated.

### **Provenance**

The collection item was transferred to AIATSIS, as part of the larger Environment Australia Library (EAL) transfer, following the closure of the EAL in 2015. The Australian Heritage Commission (AHC) Library was amalgamated with the EAL, following its closure, so it is possible that the collection item was originally part of the AHC Library collection.
