The collection comprises of material collected by Les Darcy throughout his lifetime, predominately relating to the Brewarrina region in NSW, and includes: information regarding the Brewarrina Fish Traps; Brewarrina Cultural Museum; the Yetta Dhinnakkal Correctional Centre; family history research relating to the Darcy Family and other families in the Brewarrina area; and a selection of published items.

The material contained within the collection includes: maps and plans, correspondence, interview transcripts, publications, copies of photographs, theses; reports; financial papers; invitations and event programmes; genealogical research; apprenticeship papers.

This collection contains both physical and digital material.

#### Provenance

The collection was donated to the Australian Institute of Aboriginal and Torres Strait Islander Studies by Monica Simpson in 2018.

# **Biographical history note**

Ngemba man Leslie (Les) Kenneth Darcy was born in 1935 at Brewarrina, NSW to George and Charlotte Darcy (nee Whye). After working in the shearing trade and then training as a baker, Darcy moved to Goodooga, NSW in 1960, where he took over the local bakery, eventually purchasing it and a local taxi service. Darcy was appointed a Justice of the Peace in 1964 and was elected to the NSW Aborigines Welfare Board in 1967.

Darcy was heavily involved in community ventures throughout his life, including the Anglican Diocese of Bathurst, Brewarrina Hospital Board and Brewarrina Business Centre. He was a prominent figure in the restoration of the Brewarrina Fish Traps, the establishment of the Brewarrina Cultural Museum in the late 1980s, and together with his wife Monica, served as cultural mentors at the Yetta Dhinnakkal Correctional Centre at Gongolgon, NSW.

Les Darcy passed away on 30 December 2014 at Brewarrina.

### Subseries 3 Yetta Dhinnakkal Centre, 1999-2005

The Yetta Dhinnakkal Centre, meaning "right pathway" in Ngemba language and colloquially known as Yetta, was established in 2000 as Australia's first youth/juvenile prison exclusively for Aboriginal men. The centre offered several types of educational and cultural opportunities and workshops. Darcy volunteered at the facility as a cultural mentor. The centre was closed in 2020.
