Collection Overview

Scope and Contents note

The Papers of Richard Broome contain material relating to his recorded oral histories with Aboriginal and Torres Strait Islander professional boxers. It also contains material relating to various points across his career as a historian and academic.

Series 1 contains material relating to the research, drafting and revising of various publications. These publications include 'Aboriginal Australians'; 'Aboriginal Victorians'; 'Seeking Mulga Fred'; 'A man of all tribes'; 'Aboriginal workers on the southern frontier'; 'Aborigines at work'; 'Victims and voyagers'; 'Dangerous and marvellous encounters, early Aboriginal and European contacts in the Plenty and Melbourne regions'; 'There were vegetables every year Mr Green was here'; 'The history and politics of frontier violence'. This series also contains material related to Broome's involvement with the Australian Dictionary of Biography and Oxford Dictionary of National Biography. This includes research documents and drafts for his various contributions to the dictionaries, including entries on persons such as Dave Sands, Pemulwoy (Pemulwuy), William Ricketts, Elley Bennett, Mervyn Williams, William Buckley, Joe Wallis, Jerry Jerome, and Sir Douglas Nicholls.

Series 2 contains material relating to articles on Aboriginal boxers and boxing tent. This series also contains material relating to the publication 'Sideshow Alley' which Broome co-authored with Alick Jackomos.

Series 3 contains interview transcripts for various projects. Series 5 contains material relating to Broome's research and career as a historian. This series contains meeting minutes, agendas, and other documents relating to Aboriginal Action, rebranded in 1980 as Action for Aboriginal Rights; various newspapers and

publications; Aboriginal Welfare Board reports; AIATSIS grants; conference programmes; consultancy work; and Department of Aboriginal Affairs press summaries.

The material was donated to AIATSIS by Professor Richard Broome in 2020. Broome gathered and recorded the material in the process of researching the history of Aboriginal and Torres Strait Islander boxers.

Biographical history note

Richard Broome was born in 1948. Broome lectured at La Trobe University from 1977-1981, where his academic career focused on Aboriginal history. He returned to La Trobe in 1987, being appointed Associate Professor in 1992, and Professor in 2009.

Broome is the author and co-author of many books and articles on Australian and Indigenous history. These books include 'Aboriginal Victorians', 'Aboriginal Australians' and 'A man of all tribes: the life of Alick Jackomos'. His works have won several prizes.

Broome has also authored entries on various personalities for the Australian Dictionary of Biography and the Oxford National Dictionary of Biography.
