TASMANIAN ABORIGINAL EDUCATION CONSULTATIVE COMMITTEE.

Documents relating to sacking of TAECC by Minister for Education, Tasmania. 1983-84. Typescript (processed). 1 (8 cm) box.

The Tasmanian Aboriginal Education Consultative Committee was established by election in 1979 to advise the Director-General of Education on the education and training of Aboriginal people. Funding was successfully sought from the Schools Commission for operating costs for three years. Terms of reference were approved by the Director-General after the second Committee meeting in 1979. After Schools Commission funding ceased in early 1982 the Committee approached the Tasmanian Department of Education to fund the cost of elections. This request failed and elections were held without the support of the Department. In June 1983 the Minister for Education dismissed the Committee and drew up guidelines for a new advisory body. Elections were held and the Tasmanian Aboriginal Education Advisory Council came into existence.
