Production history

These recordings were collected by Anne Scrimgeour between 30 September and 12 December 1993 during fieldwork at Warralong in the Eastern Pilbara region of Western Australia. The purpose of the field trips was to research the Nyangumarta language through the oral history narratives of Palyakulayi [Ginger Bob]. In these narratives Palyakulayi recalls his childhood living a traditional life in the Great sandy Desert, travelling to pastoral areas with his family and his life there, working and travelling with Clancy McKenna just prior to his (Palyakulayi's) initiation, and the 1946 strike and Don McLeod. The collection was deposited with AIATSIS on 3 June 2010.
