## **AN ORDINANCE**

### Relating to the Detention in State Institutions of Uncontrollable Children and Juvenile Offenders.

**B**<sup>E</sup> it ordained by the Governor-General in and over the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Seat of Government Acceptance Act 1909-1938 and the Seat of Government (Administration) Act 1910-1940, as follows:—

1. This Ordinance may be cited as the Juvenile Offenders short utle. Ordinance 1941.\*

2. The Juvenile Offenders (Detention) Ordinance 1935-1936 is Repeal. repealed.

- 3. In this Ordinance, unless the contrary intention appears- Definitions. "Court" means a Court of the Territory;
  - "State institution" means a State institution as defined in the Agreement;
  - "the Act" means the Neglected Children and Juvenile Offenders Act, 1905 of the State, in its application to the Territory;
  - "the Agreement" means the Agreement which is set out in the Schedule to the Child Welfare Agreement Ordinance 1941;
  - "the State" means the State of New South Wales.

**4**.—(1.) Where, in pursuance of the Act, a Court has power committed of to commit a child to an institution, that Court may, while the the institution. Agreement is in force, commit the child to a State institution.

(2.) Where a child is committed to a State institution in pursuance of this section, he shall, for the purposes of the Act, be deemed to have been committed to an institution established under the Act.

5. Where a Court commits a child to a State institution, the Removal of child may forthwith be removed to the State for the purpose of child to State reception into, and detention and maintenance in, a State institution.

6. Section five of the Act is amended by adding at the end of Interpretation the definition of "Child" the words "and, in the provisions of the Act relating to institutions and the committal of children to institutions, means boy or girl under eighteen years of age".
