1 September 2014	SA	SA native title bid 18 years in the making	One of the most complex native title claims in South Australian history has been resolved when the federal court recognised a native title claim by the Kokatha people. Court proceedings to resolve the claim have been ongoing since 1996. Immediately after the hearing, an indigenous land use agreement between the Kokatha people, the state government and mining giant BHP Billiton was to be created. The agreement will provide the Kokatha people with financial compensation recognising the past extinguishment of native title by the state.
