AIATSIS Summary of National Research Priority Report

Executive Summary

Overview of progress

Continuing progress has been made by AIATSIS in the last financial year with further strategic appointments, new projects and consistently high outputs aligning with three of the four national research priorities (NRPs).

Increasing engagement with the NRP Sustainable use of Australia's biodiversity has been realised through strategic alliances (staff-sharing and affiliation) with the Desert Knowledge Co-operative Research Centre, and the Kimberley Development Commission. Eight AIATSIS staff completed a major report to the National Oceans Office of DEH. The project examined Indigenous involvement in management of the south-west marine zone out to the economic exclusion zone. AIATSIS is taking a lead role in facilitating one of the key research nodes in the International Union for Quaternary Research Global Congress to be held in Cairns 2007. This will look specifically at Aboriginal and Torres Strait Islander landscape/human relationships through time. AIATSIS continues to be party to the ARC Network Bid—Discovering the past to shape the future: networking environmental sciences for understanding and understanding Australia's biodiversity.

The Indigenous Facilitation and Mediation Project of the Native Title Research Unit secured additional funding towards facilitating the development of a national network of accredited Indigenous facilitators and mediators.

The major NDLERF funded Illicit Drug Use and Policing Protocols Project and production of Good Practice Examples for different policing jurisdictions has been launched.

The joint AIATSIS–IPRIA project on cultural collections and intellectual property has been completed and launched in Canberra and Melbourne. Phase 2 of the Australian Collaboration project Success in Aboriginal Organisations has progressed well with 15 field studies completed. Additional funds to examine Indigenous management of conservation estates have also been obtained from the Poola Foundation.

Strategic nodes of research have been consolidated in the areas of Health, Governance, Education, Language and Cultural Transmission. Research Fellows have continued to seek opportunities over the last reporting period to increase the international profile of the Institute's research programs relevant to the NRPs. Visiting Fellowships and invited Scholars status were offered to AIATSIS researchers to visit the United States, England, Germany, Italy, Switzerland and India.

Digitisation monies for AIATSIS have created greater capacity to develop the AUSTRALANG language website (web-enabled Indigenous Language Database). A Language Officer has been appointed and discretionary monies sought to complete software engineering and update content.

The Native Title Research Conference brings in leading practitioners, representative bodies and government agencies to deal with cutting-edge issues surrounding land tenure, management, representation, resource access and community benefits in the national interest. This years' conference was the largest with over 500 registrations and about 100 presentations.

AIATSIS is a formal partner in the CRC for Aboriginal Health and is actively working on projects concerning emotional and social wellbeing, resilience, service-delivery and health of ATSI people in the prisons sector.

AIATSIS has become strategically involved with the Australian Bureau of Statistics in developing relevant social/cultural indicators as well as examining past ATSI census data.

Summary of total expenditure NRP and non-NRP actual investment for 2004–05

AIATSIS has three central outputs—research, collections and dissemination of information about ATSI cultures and societies. Research accounts for approximately 25 per cent of agency income. The total revenue to AIATSIS is \$7.881 million from appropriation, \$2.818 million for specific purposes and about \$2.671 million from other income (e.g. grants). The quantum available for all research is about \$3.4 million. Three of the four (original) priority goals are addressed with about \$3.0 million invested in 2005–06 to NRP-related research expenditure.

Of this sum, approximately 57 per cent came from the Commonwealth appropriation and 43 per cent from other sources:

Non-NRP related research falls into the following categories:

- Research relevant to, but not directly connected to, NRP (responding to climate change and variability, ATSI education curriculum and delivery, endangered languages, natural resource management and Indigenous governance)
- Other important issues for Australia (analysis of collections and archives, language maintenance, cultural transmission, heritage and tourism, history, cultural heritage, family history and publications from the Aboriginal Studies Press)
- Basic research that is non-breakthrough science (language database, thesaurus development, Federal Court requests, etc.).
- Consulting services, etc. (ongoing contracts to NDLERF, DCITA, DEH, OIPC and so on; representing over a third of revenue).

Over 80 per cent of AIATSIS’s total research investment for 2005–06 is targeted at research activities with potential outcomes relevant to the goals associated with NRP. The corresponding figure for 2004–05 was approximately 70 per cent.

Collaboration

- A range of research tenders, new policy proposals and ARC (linkage) grants have been prepared and submitted during 2005–06 to increase the capacity of AIATSIS to a) undertake research training of Indigenous postgraduates, b) carry out strategic policy work and analysis and c) develop Indigenous secondary school curriculum content (especially with respect to languages).
- The level of collaboration between AIATSIS staff and external domestic and international agencies and officers is of an extremely high order. There are currently research/collections projects linked with some 15 Australian universities, 12 federal government departments and statutory authorities, over 50 ATSI communities and numerous overseas Indigenous governance groups. AIATSIS is heavily networked into representative bodies (e.g. land councils) and NTRBs with more than 25 ‘live’ research collaborations.
- Tangible benefits include better resource integration, salary sharing and underwriting of fieldwork expenses from programs such as ARC Network, ARC Linkage, CRC engagement (CRC for Aboriginal Health and Desert Knowledge), placements with Fellowship schemes/discretionary monies from groups such as the Volkswagen Foundation, Poola Foundation and Reconciliation Australia. AIATSIS researchers were sponsored to make numerous presentations such as plenary papers to international conferences; e.g. Basel, Washington, New York, London. AIATSIS has also had continuing and increased capacity to bring aboard researchers for stand-alone projects, such as the National Oceans Office Indigenous Governance within the South-west Marine Region Plan, the National Drug and Law Enforcement Funded Illicit Drug Use and Policing Protocols Project (in partnership with the Australian Institute of Criminology) and the Australian Collaboration Project Success in Indigenous Organisations.

New directions and initiatives

AIATSIS received a \$13 million grant (multi-year) enabling it to digitise/conservate at-risk collections and to mobilise these more effectively for community and research access in 2005. A major staff recruitment and building program has just been completed. With the strategic appointment of new natural resource management and Indigenous governance staff AIATSIS can now more effectively engage with the National Research Priority entitled *Sustainable Use of Australia's Biodiversity*. It is also in a position to participate and tender for major projects concerning cultural heritage nominations, management and ATSI governance.

IMPACTS OF NRP and MAJOR ACHIEVEMENTS

An environmentally sustainable Australia

Social Sciences and Humanities (SS&H) enhanced goal—Responding to climate change and variability. During 2006 AIATSIS continued to form alliances and deliver products to natural resource management and governance groups including the Marine and Tropical Science Research Facility, the Torres Strait Regional Authority (specifically new Land and Sea Unit), the CSIRO sustainability group, the CRC for Desert Knowledge, the Wet Tropics Alliance and the Kimberley Development Commission. Further workshops have been delivered by the IFaMP project to Indigenous representative and land-use bodies. AIATSIS is a partner in the ARC Network—Discovering the past to shape the future: networking environmental sciences for understanding Australia's biodiversity and is co-hosting the International Quaternary Association node in Cairns in 2007.

Promoting and Maintaining Good Health

SS & H enhanced goal—Strengthening Australia's social and economic framework The activities of the Health Fellows continue to be dedicated 100 per cent towards the CRC for Aboriginal Health. Two further AIATSIS projects have become endorsed by the CRC as linked projects: these include a recently funded study of Prisoners' Health in the ACT and the History of the National Trachoma Project. The Health Fellows have contributed further towards the five CRCAH endorsed Research Programs: these are Healthy Skin; Primary Health Care; Chronic Disease; Social Determinants; and Social and Emotional Wellbeing. National and international links focusing on Indigenous resilience within the CRCAH program areas of Social and Emotional Wellbeing and Social Determinants continue to be developed by AIATSIS staff with colleagues based at Sydney University, Kimberley Aboriginal Medical Services Council in Broome, James Cook University in Cairns, Massey University in New Zealand, University of Manitoba in Canada, and the London School of Hygiene and Tropical Medicine in London.

Frontier technologies SS & H enhanced goal—promoting an innovation culture and economy. There continues to be high outputs on issues concerning development

of collections policy, intellectual property and cultural institutions and Indigenous Knowledge Systems. Three reports resulting from the joint AIATSIS–IPRIA project have been completed including Cultural Institutions, Law and Indigenous Knowledge (IPRIA), Indigenous Knowledge and Intellectual Property: Access, Ownership and Control of Cultural Materials (AIATSIS) and Framework for Community Protocols (AIATSIS). The Australian Collaboration Project Stage 2, which will profile success in local Aboriginal organisations, is well underway with 15 study sites across Australia due to be completed by end of 2006. Outputs of Stage 2 will likely include a) identification of structural/business/cultural factors underwriting successful local Aboriginal and Torres Strait Islander organisations, b) two major reports outlining results and public discussion paper(s) arising from activities of the Lead Researcher and Research Officer dedicated to the externally funded project, and c) public profiling of these successes/findings including multi-media products. The project has been successful in attracting additional sponsors and monies to broaden both its geographic scope and coverage (for example, including three examples of successful Indigenous (co)management of Conservation Estates in Northern Australia).

Safeguarding Australia

SS & H enhanced goal—understanding our region in the world. AIATSIS Researchers have produced over 100 peer-reviewed books, chapters, papers and conference presentations on myriad aspects of Aboriginal and Torres Strait Islander culture, society, governance, languages and so on. Researchers have actively engaged in national and international research networks which focus on the interaction between Indigenous peoples and ‘settler’ societies. These substantive works contribute significantly to an enhanced understanding of Australia in regional and global context. Collections staff continue to mobilise information (especially in digital format) by which Indigenous communities increasingly become more adequately profiled in international portrayals of wider Australian society.
