

INTRODUCTION



CHAIRPERSON'S MESSAGE

During the year the report of The Review of Higher Education Access and Outcomes for Aboriginal and Torres Strait Islander People (the Behrendt review) was released in July 2012, followed by the Standing Committee on Aboriginal and Torres Strait Islander Affairs report, Our Land Our Languages in 2012, both of which have implications for AIATSIS.. The national cultural policy, Creative Australia, was also released in May 2013, with a central goal to 'recognise, respect and celebrate the centrality of Aboriginal and Torres Strait Islander cultures to the uniqueness of Australian identity'. As a result of these reports' recommendations, Department of Industry, Innovation, Climate Change, Science, Research and Tertiary Education has commissioned a review of AIATSIS, which commenced at the end of June 2013.

I welcome the Review as an opportunity for the Institute to demonstrate the value of our work and its contribution to the field of Indigenous studies and the nation. This is partly demonstrated in this report in the outline of our achievements during 2012-13. The report also demonstrates the growing demands on AIATSIS and what the Institute could contribute given more resources.

AIATSIS' achievements in 2012-13 must be considered in the context of the changes in the Indigenous affairs landscape. Since its establishment almost 50 years ago, our recognised community of stakeholders has grown tremendously. Fifty years ago, Indigenous people were not counted in the census at all, but in 2011, 548,370 people who identified as being of Aboriginal and/or Torres Strait Islander origin were counted in the Census, and this is estimated to be an undercount of more than 100,000.

Research into Aboriginal and Torres Strait Islander peoples and culture was a niche pursuit, but there are now Indigenous-focused research centres in most universities and research involving Aboriginal and Torres Strait Islander peoples is being performed in mainstream faculties, schools and centres across many disciplines. The need for

leadership on matters such as ethics and culturally proficient practice is clear and growing, and AIATSIS' achievements in 2012-13 demonstrate its preeminence in this area. AIATSIS revised the Guidelines for Ethical Research in Australian Indigenous Studies, is reviewing the NHMRC ethics guidelines in partnership with the Lowitja Institute, and is now offering its high quality ethics approval service to other researchers and institutions.

While there has been progress in 'closing the gap' on outcomes for Aboriginal and Torres Strait Islander peoples, the distance still to travel demonstrates the need for well-targeted, well designed research undertaken in partnership with Indigenous communities. The skills to partner effectively with communities need to be built and maintained, and as the Chair of the AIATSIS Council, it was a great pleasure to endorse the Towards Cultural Proficiency – a phased approach to building capability 2013-2015 Strategy which will place AIATSIS at the cutting edge of culturally proficient practice.

Three Indigenous researchers completed their doctorates in 2012-13 with the support of AIATSIS, and many other of our researchers are enrolled in further education. The impact of this cannot be underestimated, in research and in the influence these examples have on educational participation and attainment by other Indigenous Australians. AIATSIS secured \$6 million in funding for Indigenous workforce development and training, an achievement that will enable AIATSIS to keep leading the way.

AIATSIS finishes the 2012-13 financial year looking forward to the celebration of its 50th anniversary in 2014. The achievements of the past year add much to celebrate, and I thank the staff and executive of AIATSIS, and the Ministers who supported us through the year, for your contribution.

PRINCIPAL'S REPORT

As the Principal of AIATSIS, I cannot help but be proud to lead an organisation that is so small, yet achieves so much. The Institute's achievements in 2012–13 once again demonstrate its value in the creation of knowledge, secure cultural material, resources, and relationships. The skills and dedication of our staff make it possible to accomplish a great deal. I only have room here to acknowledge some of our achievements, and I encourage you to read further and learn more.

From our research programs, I would like to mention the completion of the second National Indigenous Languages Survey and drafting of the Australian Curriculum: Languages – Framework for Aboriginal Languages and Torres Strait Islander Languages, and completion of a National Climate Change Research Adaption Facility project on the role of Indigenous knowledge in climate change activities. We launched a new channel to communicate

our research findings – AIATSIS Research Publications, a new imprint of the Institute's publishing arm Aboriginal Studies Press.

In our collections, digitisation targets for audio and pictorial material were exceeded, helping to ensure this precious material will still be available to communities and researchers in the future. Four very successful community access visits were also made to return audiovisual materials to communities in Cootamundra, Leeton, the Torres Strait and Kowanyama.

These visits are just one part of our response to increased demand from clients and broader community interaction. Use of the AIATSIS website alone increased by 10 per cent in 2012–13. In addition, we have seen increases in formal and informal visits to AIATSIS as well as increased our participation in events, seminars and conferences. The National Native Title Conference was once again a standout.

Operational challenges included continuing changes in the technological environment. Digitising our collections for preservation and access is just one part of our response, and we continue to plan and adjust as the digital and online world becomes ever more dominant as the platform to interact with our clients and the world. Planning in 2012–13 indicates this will need more investment in the coming years.

Our premises also offer challenges. At ten years old, our building is relatively modern and in a magnificent location, but we are already running out of room for our collection and staff, and limited in the way we can engage with our stakeholders in person. Nevertheless, AIATSIS continued to improve its environmental performance and received ACT Smart Office accreditation in 2012–13.

Significant effort has been invested in our organisational strategy and health through 2012–13. In this year of preparing for the future we have developed a new Statement of Strategic Intent, refreshed our business planning and budget processes, rebalanced our organisational structure and incorporated

workforce and succession planning into our broader operational plans. Our investment in ensuring that the cultural proficiency of our staff reflects cutting edge practice has also taken a step forward with implementation of the Towards Cultural Proficiency – a phased approach to building capability 2013–2015 Strategy now under way.

At the close of 2012–13 I am pleased to reflect on a year that leaves us stronger in terms of our strategy, planning, capability and culture. I thank the Ministers who have had oversight of AIATSIS, our Council Chair Professor Mick Dodson and all the other Council members, our committees, our members, and importantly I thank the committed staff of AIATSIS for your support and contributions in 2012–13.
