# Recent Cases (Australia)

## Griffiths v Northern Territory of Australia (with Summary) [2006] FCA 903 (17 July 2006)

Application for determination of native title in and around town of Timber Creek by the Ngaliwurru and Nungali Peoples - society of Ngaliwurru and Nungali Peoples existed at sovereignty in 1825. Case to determine whether traditional system of laws and customs has continued essentially uninterrupted since sovereignty. Held: the Ngaliwurru and Nungali Peoples have established the existence of non-exclusive native title rights over the land and waters of Timber Creek.

#### Kemp v Native Title Registrar [2006] FCA 939 (25 July 2006)

Judicial review of decision of Native Title Registrar to register Indigenous land use agreement – area agreement. Registrar's decision to register agreement set aside.

# THE SECRETARY-GENERAL MESSAGE ON THE INTERNATIONAL DAY OF THE WORLD'S INDIGENOUS PEOPLE 9 August 2006

The annual observance of this International Day recognizes the achievements of the world's indigenous people, who number more than 370 million and who live in some 70 countries. But it is also a moment to acknowledge the critical challenges they face. Much remains to be done to alleviate the poverty faced by many indigenous people; to protect them against massive violations of human rights; and to safeguard against the discrimination that, for example, forces many indigenous girls to drop out of school.

In the UN Permanent Forum on Indigenous Issues, indigenous peoples now have an official home at the United Nations. And as the proceedings of the Forum have stressed, the perspectives, concerns, experiences and world views of indigenous peoples have a crucial role to play in addressing global challenges and our efforts to achieve the Millennium Development Goals. Indeed, only by respecting cultural diversity and indigenous peoples' right to self-determination can our work together truly be called a partnership.

This year's observance is also a Day on which to welcome the recent adoption, by the first session of the new Human Rights Council, of the draft United Nations Declaration on the Rights of Indigenous Peoples. The product of many years of complex and at times contentious negotiations, the Declaration is an instrument of historic significance for the advancement of the rights and dignity of the world's indigenous peoples. Its expected adoption by the United Nations General Assembly before the end of the year will be a major achievement, with potential to further mobilize indigenous people and their partners.

On this International Day, in the Second International Decade of the World's Indigenous People, I call upon all actors -- States, indigenous peoples, United Nations bodies, international development agencies, non-governmental organizations and the private sector -- to give renewed attention and true meaning to the Decade's theme, and build a "partnership for action and dignity".

Trustees on Trial is the first book to detail the Queensland government's financial stranglehold on Aboriginal people's lives and money, and to question its management. For much of the twentieth century the Queensland government controlled the wages, endowments, pensions, workers compensation, soldiers' pay and inheritances of the state's Aboriginal people. Money it has never accounted for. In 2002 the government conditionally offered a maximum payment of \$4000 for those affected. For some, that represents \$4000 for a lifetime's work. However, most people have no idea what they're owed. Trustees on Trial explores the extensive primary evidence of financial (mis)management in terms of national and international case law. It demonstrates there is ample precedence for our courts to declare Queensland has a duty to account. This would reverse the onus of proof from the individual to the State.

## **OHCHR Indigenous Fellowship Programme**

The aim of the Indigenous Fellowship Programme (IFP) is to give Indigenous peoples the opportunity to gain knowledge on the UN system and mechanisms dealing with human rights in general and Indigenous issues in particular so they can assist their organizations and communities in protecting and promoting the rights of their people.

II. Components:

The IFP is composed of 4 different linguistic programmes:

English speaking programme (sessions imparted in English): The English speaking component of the Indigenous Fellowship Programme began in 1997, as an OHCHR's initiative developed in the context of the International Decade of the World's Indigenous People (1995-2004).

The English speaking component of the programme generally runs for four months from May to September. The Fellows are based at the Office of the United Nations High Commissioner for Human Rights (OHCHR) in Geneva, Switzerland. The programme is an inter-active process, which consists of briefings on several topics (i.e. OHCHR's work, the UN system and mechanisms) individual and

group assignments; fellows also have the opportunity to receive training sessions with other UN agencies, including ILO, WIPO, UNESCO and UNITAR.

At the end of the Programme, each Fellow should have a general knowledge on the United Nations system, international human rights instruments and mechanisms, in particular those relevant to Indigenous peoples and be capable of giving training sessions within their communities/organizations on the knowledge acquired.

Fellows attending the English speaking component of the programme are entitled to the following: a return ticket (economy class) from the country of residence to Geneva; modest accommodation in Geneva for the duration of the Programme; health insurance for the duration of the Programme; a monthly grant to cover other living expenses in Geneva. The candidates selected for year 2006 are: Leanne Maree Liddle ( Australia), Bandana Rai ( Nepal), Baba Festus ( South Africa), Peter Cheruiyot Kiplangat ( Kenya) and Karmen Ramírez Boscán ( Colombia).

The deadline to apply to the 2007English speaking programme is: 15 August 2006.

III. General selection criteria and process

Guidelines and general criteria were adopted as follows:

- 1. Age should not be a limitation to participation in the IFP, although preference should be given to candidates in the age-bracket 25-35 years.
- 2. Formal education should not be a limitation to participation in the IFP given the socio-economic barriers confronted by many Indigenous peoples that limit access to formal educational institutions.
- 3. Candidates should have the ability and the willingness to train other Indigenous persons after the return to their respective communities/organizations.
- 4. The candidate should be proposed and his candidacy supported by his/her Indigenous organization and/or community. It is desirable that the sponsoring organization has a firm constituency or membership and that it is representative.
- 5. The Fellows should have a good working knowledge of the language, in which the programme is imparted.
- 6. The selection of fellows should reflect a gender and a regional balance.
- 7. The general human rights situation in the respective regions/countries should be taken into consideration in the selection process.

The selection process takes place as follows:

A pre-selection of 15 (first five preferences and 10 alternates) candidates is made by previous Indigenous fellows. The final selection of successful candidates is undertaken by the consultative group of the Indigenous fellowship Programme, which is composed of indigenous representatives. In view of the large number of applications, we regret to inform that only successful candidates will be contacted. Fellowship applications will only be taken into consideration if they are fully completed. They must be faxed or sent by regular post. E-mailed applications will not be taken into consideration. #### Native Title Law and Practice will be taught as part of the

Melbourne Law School's Graduate Program from 18 to 22 September.

This subject is taught by leading experts in the area of Native Title. It is designed to meet the needs of persons from a range of backgrounds including people from law firms; the resources industries; providers of financial services; government departments and public authorities, native title representative bodies and other Indigenous organizations. It is especially relevant to those in management or advisory roles who must deal with the interface between native title rights and interests and other community rights and interests. The common law and the provisions of the Native Title Act relating to the recognition and protection of native title will be closely examined, including the ways in which very recent Federal Court cases such as Jango, Risk and Rubibi have applied the principles developed by the High Court in Mabo, Ward, Yorta Yorta and other major cases. The future act provisions will also be closely examined, together with past and recent Court and Tribunal determinations concerning the right to negotiate and expedited procedure processes. In addition, there will be a focus on mediation and agreement making processes, focused upon achieving consent determinations and a range of related 'non-native title' outcomes resulting from sustainable agreements on a regional, local or project-specific basis. The Australian Film, Television & Radio School is the key national centre for the training of exceptionally gifted film, television, digital media and radio students and the high-level professional development of those already working in the industry. The Macquarie Bank Indigenous Scholarship is open to Aboriginal and Torres Strait Islander people to study directing, producing, screenwriting or documentary at the AFTRS in 2007.

The Myer One Year Indigenous Scholarship is open to Aboriginal and Torres Strait Islander people to study directing, producing, screenwriting, documentary, sound design, screen composition, editing, digital media, cinematography or design fulltime at the AFTRS in 2007.

Each scholarship stipend is \$25,000 pa. Reasonable relocation expenses will be met if moving from intrastate or interstate. Applicants granted an interview receive travel assistance. Successful scholars will commence studies at the AFTRS in late January 2007. The AFTRS is situated 15 kms from Sydney's CBD on land adjacent to Macquarie University in North Ryde. The School's facilities are excellent and include computer animation graphic and multimedia facilities, television studios, darkroom, editing suites and a huge range of camera and sound equipment. There are only 100 fulltime students at the AFTRS at any one time so everyone knows everyone else. With staff members only slightly outnumbering fulltime students this has created a supportive school community and an exciting, busy and active atmosphere.
