




#### **TSRA Fisheries Programme:**


- A commercially viable fishing industry which is 100 per cent owned by Torres Strait Islander and Aboriginal people

- Sustainable management of fisheries resources



**Torres Strait Finfish Fishery** 100% owned by Traditional Inhabitant

**Torres Strait Beche-de-Mer Fishery** 100% owned by Traditional Inhabitant

Torres Strait Tropical Rock Lobster Fishery 56.2% owned by Traditional Inhabitant 43.8% owned by TVH

Torres Strait Prawn Fishery
No Traditional Inhabitant ownership

**Torres Strait Crab Fishery** 100% owned by Traditional Inhabitant

**Torres Strait Trochus Fishery** 100% owned by Traditional Inhabitant









#### Fisheries ownership and quota leasing

- TSRA leasing of unused finfish quota generates revenue
  - ✓ Finfish Quota Management Committee
  - ✓ Over \$1M raised to date
  - ✓ \$500K investment in community initiatives
- Finfish Fishery Action Plan
- Planning for TRL quota Leasing









# **The Torres Strait Treaty**

The Torres Strait Treaty defines the maritime boundaries between Australia and Papua New Guinea.

The primary purpose of the *Torres Strait Treaty* is to protect the way of life of traditional inhabitants within the Torres Strait Protected Zone.

The Treaty sets out a framework to guide Australia and Papua New Guinea in providing for the management, conservation and sharing of fisheries resources in and around the Torres Strait Protected Zone





#### **Torres Strait Fisheries Act**



- (a) to acknowledge and protect the traditional way of life and livelihood of traditional inhabitants, including their rights in relation to traditional fishing;
- (d) to administer the provisions of Part 5 of the Torres Strait Treaty (relating to commercial fisheries) so as not to prejudice the achievement of the purposes of Part 4 of the Torres Strait Treaty in regard to traditional fishing;
- (g) to have regard, in developing and implementing licensing policy, to the desirability of promoting economic development in the Torres Strait area and employment opportunities for traditional inhabitants.







#### **Native Title Sea Claim Determination**

- Recognised Torres Strait Traditional Owner rights to access marine resources over 44,000 square kilometres of Sea Country
- How the Determination will be applied to future management arrangements is a work in progress, led by Malu Lamar (Torres Strait Islander) Corporation RNTBC
- PZJA must now notify and give Traditional Owners an opportunity to comment on proposed management action in the Sea Claim Determination Area (Part A).





### **Commercial fishing access**

- Aboriginal or Torres Strait Islander Traditional Inhabitant
- TIB licence (unlimited)
- Access to all fisheries
