11/7/2013	SA	Native title claim lodged	The Narungga people have lodged a native title claim over the York Peninsula, north east of Adelaide in South Australia. The claim area covers the entire peninsula as well as surrounding Islands. Chair of the Narungga Nations native title group Tauto Sansburry said the claim was significant for the Narungga people and will hopefully pave the way for economic and employment opportunities. The protest comes amid concerns by traditional owners that the company has not conducted thorough cultural heritage surveys throughout the area, as well as the lack of consultation. Native title claimant Damien Aidon said that the application by the ADF was lodged under Commonwealth security legislation and as such, native title claimants are not privy to information regarding the application. Dja Dja Warrung confident in Land Use Agreement	The Chair of the Dja Dja Warrung Clans Aboriginal Corporation in central Victoria, Grahame Atkinson, has described an Indigenous Land Use Agreement (ILUA) that was signed with the State Government as a 'strong foundation' on which to build an economic and cultural future. Mr. Atkinson responded to concerns that the ILUA would extinguish native title by stating that 'we believe that it will be the benchmark for other Traditional Owner groups to aspire to'. 17/7/2013	SA	Cultural artifact display opened	An Aboriginal cultural artifact display from Olympic Dam was officially opened in Port Augusta. The display centre is part of the Olympic Dam agreement between BHP Billiton and native title groups. The claims made on behalf of the Western Kangoulu and Bidjara People stretch over the Gemfields region and surrounding country. Professor Jon Altman stated that 'Indigenous people are in a very weak position in relation to native title'.
