Judge says native title is biggest disappointment	Retiring Federal Court Judge Peter Gray has said in his farewell speech that Eddie Mabo's High Court win has been 'squandered', with native title reduced to something of little practical significance. Mr Gray said that the opportunity given to Australia through the Mabo High Court decision has been missed by judges and legislators who have been averse to the unique relationship between Indigenous peoples and their lands. Mr Gray insisted that future generations should be looking to devise a new native title system that 'recognises and respects the rights of our Indigenous peoples and returns them a measure of control over what, but for colonisation, would have been indisputably theirs.' Human rights policies in mining sector	McCullough Robertson Lawyer Charles Gregory spoke at the National Native Title Conference about the increase in human rights policies in multi-national mining companies. Mr Gregory highlighted, 'in Australia, we have a very weak human rights background However, because of the impact it's had on Europe, America and South America, human rights have come to be incorporated into mining company policies, setting out the rights of Indigenous people and specifically the responsibility of companies when they are developing projects on lands owned by Indigenous peoples.' 7/6/2013	Aus.	Terms of reference for native title inquiry announced	Attorney-General Mark Dreyfus QC has announced the terms of reference for an inquiry into the <i>Native Title Act 1993</i> (Cth). The inquiry will examine the economic potential for title for native title holders. The National Native Title Council (NNTC) has welcomed the inquiry but says that the terms of reference do not go far enough. NNTC Chief Executive Officer Brian Wyatt stated that 'the terms of reference do not mention anything about more fundamental amendments to the <i>Native Title Act</i> such as reversing the burden of proof about connection to country'. 19/6/2013	Qld	Hand back of lands in Cape York	The Queensland State Government has handed back a freehold title deed over a 240,000 hectare area of western Cape York to Kowanyama traditional owners to be held in trust by the Prescribed Body Corporate. The handover, which did not include the township of Kowanyama, was described by traditional owner Monty Gilbert as being of 'special significance for the people of Kowanyama'. The deal will allow Rio Tinto to commence Iron Ore mining at the Soloman Hub operations site. The deal was struck after negotiations with Fortescue Metals Group broke down. The agreement was signed by the Government of Western Australia and joint venture development partners, Buru Energy and Mitsubishi Corporation. KRED Chief Executive Officer Wayne Bergmann stated his concern that the Bill 'has major effects on the procedural rights afforded to the traditional owners under the <i>Native Title Act</i> .'
