1/10/2013	SA	Native title compensation deal remains confidential	The Yunkuntyjatjara people in South Australia have been awarded the first consent determination in a compensation claim, but the terms of the agreement remain confidential. The compensation concerns damages to sites of cultural significance prior to native title being granted. Chief Executive of South Australian Native Title Services (SANTS), Keith Thomas, says it is an historic achievement after such a long struggle. The claim groups include the Awabakal and Guringai people of Newcastle and the Central Coast. A spokesperson from the National Native Title Tribunal (NNTT) says that areas currently under other Aboriginal groups' jurisdictions will be exempt from the claim. Controversy surrounding pipeline expansion	Members of the Port Curtis Coral Coast Native Title Claim Group have expressed concern over an area of land cleared for the expansion of a pipeline. The group claims a number of sites of cultural significance have been desecrated by a contractor. Santos has acknowledged that a contractor did clear areas around the pipeline without a cultural heritage officer present. Mirning Elders have presented a petition to South Australian Attorney-General John Wau, to postpone a native title meeting in the States far west. The group claims they have evidence that the Mirning clans are the traditional custodians of tens of thousands of hectares of land from Fowler's Bay to the WA border. The group has asked that their evidence be considered before any decision about native title is made. The call from the MCA comes amid fears that benefits of land access agreements negotiated through native title are not reaching the people they are designed to help. 29/10/2013	NT	Native title decision handed down	A native title claim over more than 11,000sq/km southwest of Mataranka in the Northern Territory has been handed down by the Federal Court. Federal Court Justice John Mansfield presided over the ceremony recognising the decision. Northern Land Council Chairman Wali Wunungmurra said 'Traditional owners will stand to gain practical and financial benefits in the event of mining or other development on the land covered'. 29/10/2013	Vic.	Land use deal takes effect	A native title deal in central western Victoria has now come into effect. The Indigenous Land Use Agreement (ILUA) between the Dja Dja Wurrung native title group and the Victorian Government was signed in March but has now been officially approved by the National Native Title Tribunal (NNTT). The ILUA gives the Dja Dja Wurrung hunting, fishing and gathering rights and also makes way for joint management of six national parks and reserves in the region. The Scheme helps fund the legal and financial needs of landholders responding to native title claims. The Scheme was scrapped under the former Federal Government.	
30/10/2013	WA	Native title claimants change legal teams	The Mantjintjarra Ngalia native title claim group has asked Central Desert Native Title Services (CDNTS) to be their legal representatives after their claim had been represented by the Goldfields Land and Sea Council (GLSC) since 2006. The native title claim covers areas of land 130 kilometres east of Wiluna in central Western Australia.
