### Some statistics

- There have been 2,217 applications made under the *Native Title Act 1993* (Cth) ('NTA') since it came into effect on I January 1994,
- 1800 of them claimant applications.
- 1,525 of them have been withdrawn or resolved without determinations being made.
- A number have been dismissed, struck out or discontinued and
- 315 have secured recognition native title exists
